## ORDER REQUIREMENTS

We ask that each order be placed with a minimum quantity of [12] units of each product. Due to high demands for [Christmas], all orders for this specific period must be placed before the [15th October]. We can't guarantee our usual delivery time if an order is submitted after this deadline.

## HAND MADE PRODUCTS

All J.L. Rocha Collections products are hand-made. As such there may be variations in size, colors, thickness, etc. This gives each product a unique and meaningful look and is part of the story and branding of J.L. Rocha Collections Leather Goods.

## PACKAGING

All products come unpackaged and may require additional folding and package prior to resale.

## PAYMENT INFORMATION

We accept payments via Credit Card and Bank Transfers.

50% Advance payment is required with your order.

50% Invoice balance and cost of shipment will be emailed to you once the order is ready to ship for payment.

If your shipment is damaged in transit you agree to contact [J.L. Rocha Collections] within [5] days of delivery. Any problems must be reported in writing or by email and the retailer cannot return goods until he has received a written authorization from J.L. Rocha Collections.
